<p><b>General</b></p>	<p>Please be advised of the following consignment instruction changes for Korea effective <b>1 April, 2010:</b></p> <p><b>1. Consignment instructions – Air and Sea shipments</b></p> <p><i>Client's FULL name as in passport, with 'Destination City' now listed , e.g. Seoul (should match the city on client's Korean customs documents) c/o your Korean agent's name, address, phone and fax numbers and email</i></p> <p>Notify: Same as above</p> <p><b>2. Shipment description must now be included on OBL/AWB. "Used household goods" alone is not sufficient. Description should read, for example, 'Used household goods and personal effects (furniture, appliances, clothes, books, toys)" etc. up to 200 characters. These items should be from the packing list and described in the manifest.</b></p> <p>Please contact your Korean agent should you have any questions.</p>		
<p><b>Korean Customs Houses</b></p>	<p>In recent years, Busan or Incheon have been the preferred Customs Houses due to work force and ease of access. Korean Customs has opened a new Customs House in Daejeon, which is in a mid-location on the Korean Peninsula. The Korean Government would like to see an increase in the use of this newly opened location. Therefore, Daejeon may become an option on future shipments to Korea.</p> <p>Final designated destination cities for delivery will be the Customs Houses of either Busan, Daejeon, Incheon or Seoul.</p> <ol style="list-style-type: none"> <li>1. Seoul Customs (located in Singal, Yongin): Residence in Seoul, Anyang, Suwon, Bundang, Southeastern area of Seoul Suburb and Gangwon Province via POE Busan</li> <li>2. Incheon Customs: Residence in Incheon, Bucheon, Ansan, Kimpo, Koyang, Paju, Munsan, Northwestern area of Seoul suburb via POE Busan/Incheon Shipment via POE Incheon with exception of delivery to Daejeon, Chungchung Province, Kwangju &amp; Jeola Province</li> <li>3. Daejeon Customs: Residence in Daejeon, Chungchung Province, Kwangju &amp; Jeola Province via POE BUSAN/INCHEON</li> <li>4. Busan Customs: Residence in Busan and suburb area and Gyungnam Province</li> </ol>

<b>Pets</b>	<p>Dogs and cats:</p> <ul style="list-style-type: none"> <li>• Health certificate, less than 7 days old from origin country.</li> <li>• Certificate of rabies vaccination, injected at least 30 days prior to departure and less than 1 year at origin country.</li> </ul> <p>Birds:</p> <ul style="list-style-type: none"> <li>• Health certificate, less than 7 days old from origin country.</li> <li>• For parrots, CITES documents have to be prepared at origin and destination countries.</li> </ul>	Duty free entry.	<p>Dogs and cats – will be released only after being inspected by an animal quarantine official at the airport of entry. If the customs documents are prepared properly, dogs/cats can be released within 24 hours.</p> <p>As it normally takes about 5-6 hours from arrival at AOE Incheon to delivery residence in Seoul, please arrange the airplane which lands at AOE in the morning time during weekdays.</p> <p>Birds – 5 days of quarantine.</p>
